

RELEASE AND HOLD HARMLESS AGREEMENT

This Release and Hold Harmless Agreement ("Release") pertains to _____ ("Participant") and the Participant's involvement in activities related to the Johnson Research Robotics Program ("Program").

If Participant is less than 18 years of age or has a legal guardian, then this release is signed by Participant's parent or legal guardian (such parent or legal guardian being referred to herein after as "Guardian"), on behalf of and binding on Guardian and Participant, and Guardian gives permission for Participant to participate and engage in all activities related to the Program, including all activities at or relating to the facilities of Johnson Research and Development, as defined below.

The undersigned hereby forever waives and releases, to the full extent permitted by law, Lonnie G. Johnson, Johnson Research and Development Company, Inc., Johnson Battery Technologies, Inc, Johnson Electro-Mechanical Systems, LLC, Excellatron Solid State, LLC, and Johnson Real Estate Investments, LLC, and all of their respective employees and agents (hereinafter referred to collectively as "Johnson Research") from any and all liability, claims, demands, injuries, damages and causes of action arising from or relating to Participant's activities in connection with the Program and/or facilities of Johnson Research located at 263 or 275 Decatur Street, Atlanta, Georgia 30312 ("Activities"). The undersigned is fully aware of the risks involved in such Activities, voluntarily accepts all risks, and releases Johnson Research from all liability relating to any accident, mishap or negligence of Johnson Research or any other person or entity. The undersigned will hold Johnson Research harmless from and indemnify Johnson Research for any liability, claims, expenses and fees, including litigation fees and reasonable attorneys' fees, arising from or relating to Participant's Activities that result in actual or alleged claims, property damage or personal injury. This Release is given in consideration and as a condition of Johnson Research's permission (subject to revision at any time) for Participant to use its facilities as a license for Activities in connection with the Program at such times and locations as Johnson Research may permit. Participant furthermore understands and hereby affirms that access to any Johnson Research facility is a privilege which may be revoked at any time at the sole discretion of Johnson Research.

This Release is binding on Participant, Parent, or Guardian (if any) and their respective heirs, executors, administrators, assigned next of kin and persons having standing to recover on account of Participant's injury or death, and shall insure to the benefit of Johnson Research, its successors and assigns. The undersigned understands that the Activities Participant will be involved in are inherently dangerous and may cause serious injuries, including bodily injury, damage to personal property, and/or death. The undersigned assumes the risk and waives any and all claims against Johnson Research of personal injury, including severe bodily injury, damage to personal property and death related to the Activities.

The undersigned represents and warrants that Participant does not have physical limitations, medical ailments, physical or mental disabilities that would limit or prevent Participant from participating in the Activities.

I HAVE READ AND AGREE WITH THE TERMS OF THE RELEASE. I UNDERSTAND THAT BY SIGNING THIS RELEASE I HAVE GIVEN UP FUTURE LEGAL RIGHTS. I HAVE SIGNED THIS WAIVER FREELY, VOLUNTARILY, AND UNDER NO DURESS OR THREAT OF DURESS. MY SIGNATURE IS PROOF OF MY INTENTION TO EXECUTE A COMPLETE AND UNCONDITIONAL WAIVER AND RELEASE OF ALL LIABILITY TO THE FULL EXTENT OF THE LAW. I AM MENTALLY COMPETENT TO ENTER INTO SUCH AN AGREEMENT. I DECLARE THAT ALL FACTS STATED HEREIN ARE TRUE AND CORRECT.

This Release is governed by and will be entrusted under the laws of the State of Georgia. The undersigned consents to the exclusive jurisdiction and venue of courts located in Atlanta, Georgia for the purpose of resolution of any claim or dispute arising from or relating to this Release.
